

Instruction Sheet No. 3: Terms and Conditions of Delivery of REMONDIS SAVA GmbH

Piece goods for the bunker – Containers on pallets –

In addition: Appendix to the Instruction Sheets No. 1, 2, 3 and 5: Materials that are not suitable for the bunker, shredder or paste (Exclusion List)

In advance of each delivery a detailed waste description in English or German language has to be provided (current analysis, safety data sheet). Likewise, a representative sample of the waste may be submitted. **Please contact us in case of deviations from the conditions specified herein!**

Consistency of the waste: solid, pasty, liquid

Possible delivery systems:

- _ Plastic and metal containers up to a volume of 200 l on pallets
- _ Plastic IBC (with a maximum of 250 kg of non-dischargeable residue)
- _ ASP-container, Big-Bags on pallets
- _ For the delivery of flammable liquids in **containers** this packaging material must be **electrically conductive** and permitted according to ATEX
- _ **Electrically conductive stretch films** (ESD: Electrostatic Discharge) are to be used for wrapping in drums on pallets

Delivery conditions (please contact us in case of deviations):

- _ Flashpoint > surrounding temperature
- _ Mercury < 3 ppm (or mg/kg)
- _ Sulphur < 1.0 %
- _ Zinc < 1.0 %
- _ Organically bound silicon < 0.5 %
- _ Phosphorus < 1.0 %
- _ Fluorine < 0.1 %
- _ No finely dispersed elemental metals (Al, Fe, Sn, Ti, Zn) and no elemental magnesium of any kind (e. g. strips, rods)
- _ No freely draining liquids with a flashpoint < surrounding temperature
- _ No solid metal parts (metal discs, iron pipes and rods, gears and castings, tubing with flange connectors, steel reinforcement, etc.)
- _ No stones or concrete lumps
- _ No spray cans
- _ Maximum edge length: 120 cm (no endless filter cloth, long tubing or long plastic foil, no wired hoses except for corresponding cuts of a maximum length of 40 cm)
- _ Thickness of metal up to max. 3 mm
- _ No iron-hooped drums, no highly elastic or tough materials
- _ In case of liquid waste 10 % of a container's volume have to be left as expansion volume
- _ Max. weight of a pallet or an IBC: 1,500 kg
- _ Max. height incl. pallet: 110 cm
- _ Labelling of containers according to legal requirements
- _ The identification of the containers and their assignment to the accompanying documents must be possible

Excluded from the acceptance in the bunker are substances that are not suitable for the bunker due to their risk potential. For this the **Appendix to the Instruction Sheets No. 1, 2, 3 and 5: Materials that are not suitable for the bunker, shredder or paste (Exclusion List)** has to be observed. Those are, for example, dusty, reactive, smelling, toxic substances. These substances – appropriately packed – can be accepted for the drum lift (see Instruction Sheet No. 4).

Completely excluded from the acceptance and not permitted are gaseous, explosive and radioactive substances, likewise chemical and biological warfare agents, genetically modified materials, as well as asbestos and carbon fibre reinforced plastics.
