

General Terms of Deliveries of REMONDIS SAVA GmbH

Basics of International Shipments to REMONDIS SAVA GmbH

1. An international shipment of waste to REMONDIS SAVA GmbH has to be carried out according to the procedures of regulation No 1013/2006/EC of the European Parliament and the Council of 14 June 2006 on shipments of waste.
2. Only waste for which REMONDIS SAVA GmbH has a permit will be accepted. The list of the permitted codes according to the European Waste Catalogue (EWC) is part of the Efb certificate and is available for download at <https://www.remondissava.de/en/certificates/>.
3. The waste must be prepared and packed according to the Terms and Conditions of Delivery of REMONDIS SAVA GmbH (Instruction Sheets No. 1–8 as well as their appendices, in English and/or German language) in their currently valid form. These are available for download at: <http://www.remondissava.de/en/plant/terms-of-delivery/>.
4. The declaration of the waste is to be attached to the notification. The following parameters usually have to be determined and/or declared by the waste generator:
 - _ Consistency (solid, pasty, liquid)
 - _ Calorific value
 - _ Residue on ignition
 - _ Contents of:
 - _ Mercury (Hg)
 - _ Halogens (single values of fluorine, chlorine, bromine, iodine)
 - _ Total sulphur
 - _ Alkali metals (single values of sodium and potassium)
 - _ Organically bound silicon
5. Binding information for the transport announcement is supplied by the client by filling in the form "Date inquiry for deliveries". The use of this form is explained in "Appendix A". A delivery date will only be allocated by REMONDIS SAVA GmbH after the client has sent the filled-in form "Date inquiry for deliveries". REMONDIS SAVA GmbH reserves the right to reject any delivery that is not compliant with the form of delivery mutually agreed on.
6. The delivery date is coordinated by the scheduling department of REMONDIS SAVA GmbH.

Prior to the delivery of laboratory chemicals according to Instruction Sheet No. 4 of REMONDIS SAVA GmbH (available for download at https://www.remondissava.de/fileadmin/user_upload/remondis_sava/merkblaetter/en/2025/Instruction_Sheet_4_REMONDIS_SAVA_02-2025.pdf) a list of the containers with information on their gross weight and their complete content must be submitted.
